DfE's highly customised Meridio enterprise content management system required in-depth analysis and reverse engineering by the Proventeq team to ensure that the design of the migration encapsulated the scope of the project and fulfilled all of the organisation's specific requirements.

## Win Results

#### **Complex legacy platform**

DfE's entirely bespoke, domain-specific application required reverse engineering due to a lack of internal platform administration expertise.

#### Inconsistent source metadata

File types & extensions were incorrectly stored, requiring a deep file inspection to determine the correct file types prior to migration to SharePoint Online.

#### Full text conversion of image scans:

Over 700,000 scanned images needed optical character recognition and full text extraction prior to migration to the SharePoint Online.

AvalonBay Communities were looking to migrate a large volume of content – i.e. more than 120 million emails and documents – from IBM FileNet P8 to SharePoint Online.

## Win Results

#### \$100K Reduction in Annual Licensing

By decommissioning the IBM FileNet and eDiscovery platforms, AvalonBay Communities has been able to make significant licensing and infrastructure costs savings: \$100K reduction in annual costs.

#### **Reduction in Storage Costs**

DLF took the decision to implement SharePoint Online to be able to manage content and information on a granular level; provide staff and external stakeholders with the flexibility of a centralised Content Services solution, and reduce the overall infrastructure costs.

With over 2.4 million content items held in an ageing IBM FileNet P8 instance, and a requirement to minimise business downtime during the migration process, DLF chose Proventeq's Migration Accelerator to discover, analyze, enhance, classify and migrate their content portfolio.

## Win Results

#### **Smooth Transition To Sharepoint**

The adoption of both a pilot migration which ensured that the proposed strategy met the needs of the project and the implementation of an incremental production migration process helped DLF avoid any costly or time-consuming technical issues.

#### **Reduced Total Cost Of Ownership**

Due to an existing investment in Microsoft's Office 365 platform, DLF found that by moving the content out of IBM FileNet P8 and decommissioning the IBM system there has been a significant reduction in the total cost of ownership of their ECM infrastructure.

#### **Robust Information Protection**

While overarching control over complex granular permissions had proved problematic in FileNet P8, adoption of Microsoft's Azure Information Protection allows DLF to meet a key goal of achieving granular control of view, read and print permissions on externallyshared content.

McAllister Olivarius were operating on an iManage Worksite system. The limitation of managing content from four separate divisions and entities within the organisation iManage resulted in the need for a more structured and inclusive online environment.

To address this situation, Microsoft's SharePoint Online product was chosen to provide a complete and extensible Content Services component for the practice. solution.

## Win Results

#### **Data Consistency And Reliability**

With a high number of legally sensitive files to be migrated, frequent item-level audits were carried out on asset integrity and to preserve important case files, ensuring a flawless degree of data consistency was maintained required to meet the challenges of internal governance and regulatory control.

#### **Practical Content Structure**

By tailoring a new structuring system that matched the brief, we enabled McAllister Olivarius to effectively separate content from each of the four entities, which make up the organisation. Additionally, each corporation was disconnected and remapped into its own digital landscape.

#### **More Powerful Administration & Data Loss Prevention**

Migration Accelerator's trial function created a detailed map for the content and was able to be completed to an extremely strict timescale, ensuring the switchover did not impact the client's business negatively.
