



Smart Loader

Automatically ingests data from your data sources including, OMS providers, Fund Administrators, Prime Brokers, Counterparties and other data providers. Smart Loader supports multiple protocols types including FTP, SFTP, email, http, https, can ingest different data file types include Excel, pdf, csv, txt, xml, etc., and supports encrypted channels and files.

File Drop

Easily upload data files to your DataHub for immediate ingestion and processing. Furthermore, all files ingested by the Smart Loader are stored in the File Drop, along with processing status. File Drop

shows you the history of all data that is input into your DataHub. Quick data corrections are as easy as uploading a corrected file to File Drop for immediate processing.

Domain Specific Data Model

Our DataHub domain model normalizes, aggregates and makes available one-true version of your data in a dedicated, noncomingled data store.

Self-Service Analytics

Easily and quickly create unlimited analytics reports which are immediately available. No custom development is needed to create your own analytics or reports.

ANALYTICS & REPORT MODULES

Front Office Analytics

Portfolio management and trading focused, includes daily P&L, MTD, YTD for portfolios, by strategy, asset class, trader, region; gross return and net return at different levels; positions by strategy, asset class, names, custody, hedge details; cash projections by currency; asset class specific analysis, e.g., FX Forward maturity profile, Bank Debt maturity, Bond maturity; Trade blotter, settled trades, unsettled trades.

Middle Office Analytics

Focuses on the day-to-day operational processes and operational risk mitigation. It includes position, trade, cash, cash activity and P&L reconciliation, two-way and three-way reconciliation between OMS, prime brokers (multi-prime) and fund administrator; Market value analysis; broker commission analysis for multiple asset classes; margin dashboard.

Risk Analytics

Includes daily and monthly risk analysis for risk and as well as investor reporting. It includes fund level statistics computation such as alpha, beta, Sharpe ratio, Sortino ratio, volatility, downside deviation, leverage, largest single day gain/loss, number of positive and negative days; exposure, attribution by strategy, asset class, credit rating, direction, trade group, top n; performance comparison with benchmarks; Computation of hedge P&L, IRR at position or hedge position level.

Regulatory Compliance and Operational Due Diligence

Provides 13F assets monitoring, 13F report extract; Institutional investor specific extracts and reports; Monitoring of Investment guidelines.
