Manual processing

- Documents manually classified, categorized and verified for accuracy

Data Entry

- Data from each documents are manually entered into systems like ERP etc.

Review

- Data entered must be quality checked and reviewed before it can be integrated with downline systems.

Total cost and time

- The total cost and time incurred for processing is high.

IDP Processing

Auto classification of documents

- Auto Classification of documents into specific categories like claims, forms etc. using supervised machine learning

Auto Extraction of data

- Data entered must be quality checked and reviewed before it can be integrated with downline systems.

Data integration with downstream systems

- Once the data is extracted, it can be integrated with downstream systems like ERP applications, databases and other applications with minimal review

Features

- Ingest documents- pdf, images, MS word, email
- Using supervised machine learning to auto classify documents as Invoices, forms, claims etc.
- Optical character recognition (OCR) and extraction of data from complex documents – scanned, handwritten, digital
- Review & Validation of the extracted data
- Integration of the extracted data with downline applications and databases via REST API and export structured data such as json, excel



Use Cases


- **Finance:** Accounts Payable – process scanned invoices and integrate with ERP system

Modules

- **Operator:** used by **Operator** to upload document, and view classified & extract document content and export
- **Training:** used by admin to train various classes / categories of documents and build classification model for all classes and content extraction model per class / category
