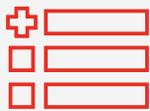

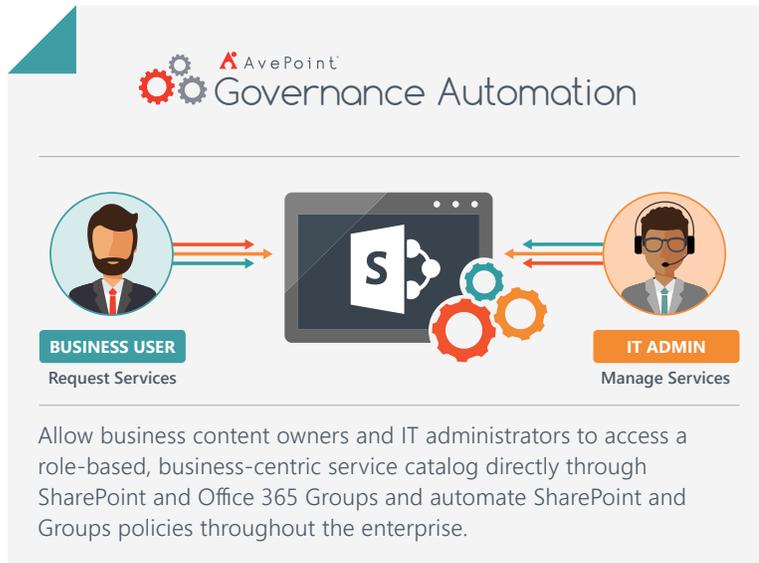


#### Lifecycle

- Supports SharePoint Server 2016, 2013, 2010, Office 365 (SharePoint Online, Microsoft Teams, and Office 365 groups) and hybrid deployments
- Dynamic Service Creation option adds flexible and intelligent logic into service request forms, allowing admins to easily satisfy complex provisioning workflows with minimal effort and maintenance

- Active Directory (AD) integration allows Governance Automation to directly add users into any existing AD group or create new groups when granting permissions or requesting a site collection
- Complies with Voluntary Product Accessibility Template to support disabled accessibility

## Supported Service Request Types

### Provisioning

- Automatically provision policy-based Office 365 Groups, Microsoft Teams, and SharePoint site collections, sites, lists, and libraries
- Apply conditional logic to options and fields on request forms based on who the requestor is or what they are requesting
- Automatically apply appropriate auditing, branding, business templates, taxonomy and classification, backup, archiving, storage, and permissions policies to sites and site collections upon creation for consistency and IT efficiency
- Centralize and reuse policy definitions to enhance consistency across service requests for storage management, site and Office 365 Groups leases, and inactivity with a flexible policy wizard
- Site Information Cards/Panel – For either SharePoint classic sites or SharePoint Online Communication sites, surface information such as metadata, ownership, and service request directly within the site
- Mobile app – available for Android and iOS devices – allows approvers to address requests quickly and on the go, minimizing any impact on user productivity

### Management

- Manage ownership, classification, and content policies for SharePoint sites, Microsoft Teams, and Office 365 Groups
- Automate enterprise content migration and restructuring while maintaining all content, configurations, security settings, and metadata
- Increase application reliability with the ability to request sample production data for development or testing environments
- Utilize a centralized dashboard with security-trimmed access to allow administrators, and site and Office 365 Group owners to view site collection, site and Office 365 Group reports, all task reports, and user activity reports, including requests and permissions changes
- Reroute SharePoint, Microsoft Teams, and Office 365 Group access requests to service requests to ensure compliance with corporate security policies
- Trigger permission, ownership and membership recertification tasks for sites, Microsoft Teams, or Office 365 Groups to confirm business ownership to maintain

accountability

### Lifecycle

- Utilize automated reports and approval processes to ask accountable business users to proactively delete or archive sites or Office 365 Groups that are inactive or have pending lease expirations
- Increase transparency of content ownership and access by maintaining an up-to-date list of accountable business users for each site collection, site or Office 365 Groups throughout its lifecycle
- Implement an automated, multi-stage ownership nomination process to drive lifecycle decisions and ensure contacts are accurate and up-to-date
- Automatically enforce end-of-life workflows for dead account cleaning to remove or transfer permissions for deactivated users, stale content, and irrelevant sites
