1 Introduction

A Functional Requirements Document and Fit Gap Analysis Document were prepared based upon business requirements described by Your Company's core team users during the planning process. The Fit Gap Analysis Document is a supporting document to the FRD, which identifies any gaps found in the functionality, along with implementation options identified.
