# Who is it for?

**Albanian Fiscalization** is a complete software solution related to the mandatory fiscalization of Albanian companies with VAT registration. According to the law, businesses are obliged to report online cash and cashless transactions with issued invoices.

The application enables businesses to establish a connection between Dynamics 365 Business Central and the SelfCare tax authority's system. After posting a transaction in Business Central, the app sends a request with an .xml file for every type of document that should be fiscalized and gets back a confirmation with fiscal numbers from the tax authority.

**Albanian Fiscalization** app provides a completely automatic online process with no need for physical devices to be installed.

- All Albanian companies with VAT registration
- All Albanian companies issuing sales invoices

The application is integrated with Microsoft Dynamics 365 Business Central.
