In order to maximize Your benefits, please go to <a href="www.myservice.Surface.com">www.myservice.xbox.com</a> if You purchased the "XBOX PLAN") and register Your Service Contract within 10 days of purchase. Failure to do so may result in significant service delays when You have a Claim.

CONSUMER RIGHTS: FOR CONSUMERS IN TERRITORIES THAT HAVE THE BENEFIT OF CONSUMER PROTECTION LAWS OR REGULATIONS, THE BENEFITS CONFERRED BY THIS SERVICE CONTRACT ARE IN ADDITION TO ALL RIGHTS AND REMEDIES PROVIDED UNDER SUCH LAWS AND REGULATIONS. NOTHING IN THIS SERVICE CONTRACT SHALL PREJUDICE CONSUMER RIGHTS GRANTED BY APPLICABLE MANDATORY LAWS, INCLUDING CONSUMER'S RIGHT TO THE REMEDIES UNDER STATUTORY WARRANTY LAW AND TO SEEK DAMAGES IN THE EVENT OF TOTAL OR PARTIAL NON-PERFORMANCE OR INADEQUATE PERFORMANCE BY US OF ANY OF OUR CONTRACTUAL OBLIGATIONS.

**CONGRATULATIONS!** Thank You for Your recent purchase of "Microsoft Complete". Please keep this important terms and conditions document ("Service Contract"), and Proof of Purchase together in a safe place, as these will be needed at time of a Claim. The information contained in this Contract document is intended to serve as a valuable reference guide to help You determine and understand WHAT IS COVERED under Your Contract. #### **DEFINITIONS**

Throughout this Contract, the following capitalized words have the stated meaning –

- "We", "Us", "Our", "Provider", "Obligor", "Administrator": the party
  or parties obligated to provide service under this Contract as the service
  contract provider/obligor, as well as handle the administration under this
  Contract as the service contract Administrator AS SPECIFIED IN THE
  "SPECIAL JURISDICTIONAL REQUIREMENTS" SECTION OF THIS
  CONTRACT AND APPLICABLE TO YOUR JURISDICTION.
- "Retailer": the seller that has been authorized by Us to sell this Contract to You
- "You", "Your": the purchaser/owner of the Product(s) covered by this Contract.
- "Product(s)": the item(s) that You originally purchased, or at Our discretion, a Replacement item provided by Us, that is to be covered under this Contract.
- "Original Purchase Price": the amount paid by You for the covered Product(s); excluding any applicable taxes and/or fees, as indicated on Your Proof of Purchase.
- "Proof of Purchase": the original purchase receipt provided at the point
  of sale that confirms the date in which the Service Contract and Product
  were purchased, as well as the Term period and specific Coverage Plan
  Option.
- "Term": the period of time in which the provisions of this Contract are valid.
- "Claim": a demand for payment in accordance with this Contract sent by You.

- "Breakdown": the mechanical and/or electrical failure of Your Product to perform its intended function, including defects in materials or workmanship; occurring during normal use of the Product.
- "Power Surge": damage to the Product resulting from an oversupply of
  voltage to Your Product while properly connected to a surge protector
  approved by the Underwriter's Laboratory Inc. (UL), but <u>not</u> including
  damages resulting from the improper installation or improper connection
  of the Product to a power source.
- "Deductible": the amount You are required to pay, per Claim, for services covered under this Contract (if any).
- "ADH", "ADP": accidental damage from handling; such as damage resulting from dropping the covered Product, liquid spillage, or in association with screen breakage. ADH/ADP Coverage is not available for all Product types or Plan options.
- "Repair": the actions We take to mend, remedy, or restore Your Product
  to a sound functioning state following a covered Breakdown. Parts used
  to Repair the Product may be new, used, refurbished or non-original
  manufacturer parts that perform to the factory specifications of the
  original Product.
- "Replace" or "Replacement(s)": delivery to You of a replacement item
  in the event We determine Your previous Product is not suitable for
  Repair. We reserve the right to Replace Your defective Product with a new,
  rebuilt or refurbished item of equal or similar features and functionality.

# SERVICE CONTRACT TERM - EFFECTIVE DATE OF COVERAGE

- 1. Coverage for damages to Your Product resulting from Power Surge or, if purchased/applicable, ADH/ADP begins upon Product purchase date and continues for the Term shown on Your Proof of Purchase.
- 2. Coverage for a Breakdown begins upon expiration of the shortest portion of the manufacturer's original parts and/or labor warranty and continues for the remainder of Your Term shown on Your Proof of Purchase.

# **PRODUCT ELIGIBILITY**

In order to be eligible for Coverage (defined below) under this Contract, the merchandise must be: (a) purchased from an authorized Retailer; and (b) not covered under any other insurance, warranty, guarantee and/or service contract providing the same benefits as outlined herein.

# WHAT IS COVERED - GENERAL

During the SERVICE CONTRACT TERM described above, in the event of a covered Claim this Contract provides labor and/or parts required to Repair the covered Product, or at Our sole discretion, Replacement of the covered Product in lieu of Repair ("Coverage").



Coverage described in this Contract does not replace or provide duplicative benefits during any active manufacturer's warranty period. During such period, anything covered under that warranty is the sole responsibility of the manufacturer and will not be considered under this Contract; regardless of the manufacturer's ability to fulfill its obligations. We will Repair or Replace Your Product pursuant to the provisions of this Contract. If We decide to Replace Your Product, technological advances may result in a Replacement with a lower selling price than the previous covered Product, and no reimbursement based on any Replacement item cost difference will be provided. Any and all parts or units Replaced under this Contract become Our property in their entirety. When a Replacement is applicable and provided in lieu of Repair, any accessories, attachments and/or peripherals that are integrated with the Product, but that were not provided and included by the manufacturer in the packaging and with the original sale of the covered Product, will NOT be included with such Replacement.

## **COVERAGE PLAN OPTIONS**

(As indicated on the Proof of Purchase and applicable to You)

#### 1. LAPTOP/DESKTOP PLANS:

A) LAPTOP/DESKTOP PLAN (*Breakdown ONLY*) – If a Laptop or Desktop Plan ("Plan") has been purchased (as indicated on Your Proof of Purchase), Coverage includes that which is described in the "WHAT IS COVERED – GENERAL" section above. NOTE: ADH is not covered under this Plan Option.

DEDUCTIBLE - LAPTOP/DESKTOP PLAN (Breakdown ONLY): Under this Plan, no Deductible payment is required.

<u>LIMIT OF LIABILITY – LAPTOP/DESKTOP PLAN (Breakdown ONLY)</u>: During Your Plan Term, the maximum amount that We are obligated to pay in connection with all Claims pursuant to this Contract is (at Our sole discretion):

- For Breakdown Covered Claims:
  - Aggregate Repair Limit: unlimited repairs to Your covered Product up to the amount equal to the Original Purchase Price of the covered Product. Once this aggregate repair limit has been reached, Our obligations will be considered fulfilled and coverage under Your Planends
  - Replacement Limit: up to one (1) replacement of Your covered Product in the event We determine that the covered Product cannot be repaired. If Your Product has already been replaced once for a Breakdown cause (such as Breakdown due to mechanical/electrical failure or damage resulting from Power Surge), Our obligations will be considered fulfilled and coverage under Your Plan ends.
- For ADH Claims:
  - NOT COVERED.
- B) LAPTOP/DESKTOP PLAN (*Breakdown and ADH*) If a Laptop or Desktop Plan including ADH ("Plan") has been purchased (as indicated on Your Proof of Purchase), Coverage includes that which is described in the "WHAT IS COVERED GENERAL" section above plus ADH Coverage.

<u>DEDUCTIBLE – LAPTOP/DESKTOP PLAN (Breakdown and ADH):</u> Under this Plan, a \$49.00 Deductible per covered Claim must be paid at the time services are authorized by the Administrator.

<u>LIMIT OF LIABILITY – LAPTOP/DESKTOP PLAN (Breakdown and ADH:</u> During Your Plan Term, the maximum amount that We are obligated to pay in connection with all Claims pursuant to this Contract is (at Our sole discretion):

- For Breakdown Covered Claims:
  - Aggregate Repair Limit: unlimited repairs to Your covered Product up to the amount equal to the Original Purchase Price of the covered Product. Once this aggregate repair limit has been reached, Our obligations will be considered fulfilled and coverage under Your Plan ends.
  - Replacement Limit: up to one (1) replacement of Your covered Product in the event We determine that the covered Product cannot be repaired. If Your Product has already been replaced once for a Breakdown cause (such as Breakdown due to mechanical/electrical breakdown or damage resulting from Power Surge), Our obligations for Breakdown Coverage will be considered fulfilled and Breakdown Coverage under Your Plan ends.
- For ADH Covered Claims:
  - Aggregate Repair Limit: unlimited repairs to Your covered Product up to twice the amount of the Original Purchase Price of the covered Product. For any one covered Claim, the maximum amount We will pay will not exceed to the Original Purchase Price of Your covered Product. Once this aggregate repair limit has been reached, Our obligations will be considered fulfilled and coverage under Your Plan ends.
  - Replacement Limit: up to two (2) replacements for Your covered Product in the event We determine that the covered Product cannot be repaired. Once Your Product has already been replaced twice for an ADH cause, Our obligations for ADH Coverage will be considered fulfilled and ADH Coverage under Your Plan ends.

**NOTICE – ABOUT REPLACEMENTS UNDER ANY "LAPTOP/DESKTOP PLAN":** Determination of whether a defective Product will be Repaired or Replaced is at Our sole discretion. If a Replacement is provided, it will be considered the covered "Product" as referenced in the provisions of this Contract, and if the Term is still effective and the limit of liability has not been fulfilled, Coverage for the Replacement Product will automatically continue for the remainder of the Term. *NOTE: A Repair or Replacement does not extend the Term.* 

If We choose to provide a Replacement, We may provide advanced exchange service. If We provide advanced exchange service, the Replacement Product will be delivered to You in advance of Our receipt of the defective Product. IN EXCHANGE, THE DEFECTIVE PRODUCT MUST BE RETURNED TO US WITHIN TEN (10) CALENDAR DAYS OF CONFIRMED DELIVERY RECEIPT OF THE REPLACEMENT PRODUCT. If the defective Product is not returned to Us within ten (10) calendar days of confirmed delivery receipt of the Replacement Product, You will be assessed a non-returned device fee equal to the MSRP of the Replacement Product. WE RESERVE THE RIGHT TO REPLACE A DEFECTIVE PRODUCT WITH A NEW, REBUILT OR



REFURBISHED ITEM OF EQUAL OR SIMILAR FEATURES AND FUNCTIONALITY, WHICH MAY NOT BE THE SAME MODEL OR COLOR AS THE PREVIOUS COVERED PRODUCT.

### 2. SURFACE OR TABLET PLAN:

A) SURFACE OR TABLET PLAN (Breakdown ONLY) – If a Surface or Tablet Plan ("Plan") has been purchased (as indicated on Your Proof of Purchase), Coverage includes that which is described in the "WHAT IS COVERED – GENERAL" section above. NOTE: ADH is not covered under this Plan Option.

DEDUCTIBLE - SURFACE OR TABLET PLAN (Breakdown ONLY): Under this Plan, no Deductible payment is required.

<u>LIMIT OF LIABILITY – SURFACE OR TABLET PLAN (Breakdown ONLY)</u>: During Your Plan Term, the maximum amount that We are obligated to pay in connection with all Claims pursuant to this Contract is (at Our sole discretion):

- For Breakdown Covered Claims:
  - Aggregate Repair Limit: unlimited repairs to Your covered Product up to the amount equal to the Original Purchase Price of the covered Product. Once this aggregate repair limit has been reached, Our obligations will be considered fulfilled and coverage under Your Plan ends.
  - Replacement Limit: up to one (1) replacement of Your covered Product in the event We determine that the covered Product cannot be
    repaired. If Your Product has already been replaced once for a Breakdown cause (such as Breakdown due to mechanical/electrical failure
    or damage resulting from Power Surge), Our obligations will be considered fulfilled and coverage under Your Plan ends.
- For ADH Claims:
  - NOT COVERED.
- B) SURFACE OR TABLET PLAN (*Breakdown and ADH*) If a Surface or Tablet Plan including ADH ("Plan") has been purchased (as indicated on Your Proof of Purchase), Coverage includes that which is described in the "WHAT IS COVERED GENERAL" section above plus ADH Coverage.

<u>DEDUCTIBLE – SURFACE OR TABLET PLAN (Breakdown and ADH):</u> Under this Plan, a \$49.00 Deductible per covered Claim must be paid at the time services are authorized by the Administrator.

<u>LIMIT OF LIABILITY – SURFACE OR TABLET PLAN (Breakdown and ADH:</u> During Your Plan Term, the maximum amount that We are obligated to pay in connection with all Claims pursuant to this Contract is (at Our sole discretion):

- For Breakdown Covered Claims:
  - Aggregate Repair Limit: unlimited repairs to Your covered Product up to the amount equal to the Original Purchase Price of the covered Product. Once this aggregate repair limit has been reached, Our obligations will be considered fulfilled and coverage under Your Plan ends.
  - Replacement Limit: up to one (1) replacement of Your covered Product in the event We determine that the covered Product cannot be repaired. If Your Product has already been replaced once for a Breakdown cause (such as Breakdown due to mechanical/electrical breakdown or damage resulting from Power Surge), Our obligations for Breakdown Coverage will be considered fulfilled and Breakdown Coverage under Your Plan ends.
- For ADH Covered Claims:
  - Aggregate Repair Limit: unlimited repairs to Your covered Product up to twice the amount of the Original Purchase Price of the covered Product.   - Replacement Limit: up to two (2) replacements for Your covered Product in the event We determine that the covered Product cannot be repaired. Once Your Product has already been replaced twice for an ADH cause, Our obligations for ADH Coverage will be considered fulfilled and ADH Coverage under Your Plan ends.

**NOTICE – ABOUT REPLACEMENTS UNDER ANY "SURFACE OR TABLET PLAN":** Determination of whether a defective Product will be Repaired or Replaced is at Our sole discretion. If a Replacement is provided, it will be considered the covered "Product" as referenced in the provisions of this Contract, and if the Term is still effective and the limit of liability has not been fulfilled, Coverage for the Replacement Product will automatically continue for the remainder of the Term. *NOTE: A Repair or Replacement does not extend the Term.* 

If We choose to provide a Replacement, We may provide advanced exchange service. #### 3. XBOX PLAN (BREAKDOWN ONLY):

If You purchased the Xbox Replacement Plan ("Plan") as indicated on Your Proof of Purchase, Your Plan provides Breakdown Coverage plus the benefits outlined below for the following components when such components are purchased from a Microsoft Retailer as a single bundle or package:

- One (1) Xbox console Product;
- One (1) Kinect motion sensing device Product; and
- Up to two (2) Xbox standard controller Products.

**Replacement Benefits –** In the event of a covered Claim, Your Plan provides:

- Up to one (1) Replacement of Your originally purchased Xbox console Product;
- Up to one (1) Replacement of Your originally purchased Kinect motion sensing device Product; and
- Up to two (2) Replacements of Your originally purchased Xbox standard controller Product.

WE RESERVE THE RIGHT TO REPLACE A DEFECTIVE PRODUCT WITH A NEW, REBUILT OR REFURBISHED ITEM OF EQUAL OR SIMILAR FEATURES AND FUNCTIONALITY, WHICH MAY NOT BE THE SAME MODEL OR COLOR AS THE PREVIOUS COVERED PRODUCT.

<u>DEDUCTIBLE - XBOX PLAN:</u> Under this Plan, no Deductible payment is required.

<u>LIMIT OF LIABILITY – XBOX PLAN:</u> Under this Plan, the maximum amount that We are obligated to pay in connection with all Claims made pursuant to Your Plan is up to the Original Purchase Price of Your Product.

- If Your Xbox console and Kinect motion sensing device have each already been replaced once, You will no longer be eligible for benefits in association with these two Product components of Your Xbox/Kinect system under Your Plan.
- If Your Xbox standard controller Product has already been replaced twice, You will be no longer eligible for benefits in association with this component of Your Xbox/Kinect system under Your Plan.

At any time during Your Contract Term, if We have provided a Replacement Xbox console, a Replacement Kinect motion sensing device, and two (2) Replacement Xbox standard controller Products, Our obligations will be considered fulfilled and all Coverage under Your Plan ends.

NOTICE – NO COVERAGE FOR ADH UNDER THE "XBOX PLAN": Coverage for damages resulting from accidental damage from handling (ADH) is not covered and is not available for purchase.

#### 4. SMARTPHONE PLAN WITH BREAKDOWN & ADH:

If You purchased the Smartphone Plan including ADH ("Plan") as indicated on Your Proof of Purchase, Your Plan provides Breakdown Coverage and ADH Coverage. Additionally, Your Plan provides:

- **Defective Battery Replacement:** Replacement of the Product's original rechargeable battery unit that was provided by the manufacturer and included with the purchase of the covered Product. (Note: benefit is limited to one (1) battery Replacement during Your Term.)
- Damaged or Defective Buttons or Connectivity Ports: labor and/or parts required to Repair damaged or defective buttons or connectivity
  ports located on the Product, when such damage / defect results in Product functional impairment.
- **Defective Pixels:** labor and/or parts required to Repair defective pixels on the display area of Your Product, when at least three (3) pixels are defective.
- **Dust, Internal Overheating, Internal Humidity/Condensation:** labor and/or parts required to Repair Breakdown of Your Product resulting from dust, internal overheating, internal humidity or condensation; occurring during normal use of the Product.

<u>DEDUCTIBLE – SMARTPHONE PLAN (Breakdown and ADH):</u> Under Your Plan, You are required to pay a \$49.00 Deductible per covered Claim, which must be paid at the time services are authorized by the Administrator.

<u>LIMIT OF LIABILITY – SMARTPHONE PLAN (Breakdown and ADH):</u> During Your Plan Term, the maximum amount that We are obligated to pay in connection with all Claims pursuant to this Contract is (at Our sole discretion):

- Aggregate Repair Limit: unlimited repairs to Your covered Product up to twice the amount of the Original Purchase Price of the covered Product. Once this aggregate repair limit has been reached, Our obligations will be considered fulfilled and coverage under Your Contract ends.
- Replacement Limit: up to two (2) replacements for Your covered Product in the event We determine that the covered Product cannot be repaired. Once Your Product has already been replaced twice, Our obligations will be considered fulfilled and coverage under Your Contract ends.

**NOTICE – ABOUT REPLACEMENTS UNDER A "SMARTPHONE PLAN":** Determination of whether a defective Product will be Repaired or Replaced is at Our sole discretion. If a Replacement is provided, it will be considered the covered "Product" as referenced in the provisions of this Contract, and if the Term is still effective and the limit of liability has not been fulfilled, Coverage for the Replacement Product will automatically continue for the remainder of the Term. *NOTE: A Repair or Replacement does not extend the Term.* 

If We choose to provide a Replacement, We may provide advanced exchange service. #### 5. MICROSOFT BAND PLAN (WITH BREAKDOWN & ADH):

If You purchased the Microsoft Band Plan including ADH ("Plan") as evidenced on Your Proof of Purchase, Your Plan provides straight Product Replacement for covered Breakdown, ADH or Power Surge damage.

<u>DEDUCTIBLE – MICROSOFT BAND PLAN with ADH:</u> Under this Plan, no Deductible payment is required.

<u>LIMIT OF LIABILITY – MICROSOFT BAND PLAN with ADH:</u> During Your Plan Term, the maximum amount that We are obligated to pay in connection with all Claims pursuant to this Contract is (at Our sole discretion) up to one (1) replacement of Your original covered Product. If Your original Product has already been replaced once for any reason, Our obligations will be considered fulfilled and coverage under Your Contract ends.

NOTICE – ABOUT REPLACEMENTS UNDER THE "MICROSOFT BAND PLAN": If We choose to provide a Replacement, We may provide advanced exchange service. If We provide advanced exchange service, the Replacement Product will be delivered to You in advance of Our receipt of the defective Product. IN EXCHANGE, THE DEFECTIVE PRODUCT MUST BE RETURNED TO US WITHIN TEN (10) CALENDAR DAYS OF CONFIRMED DELIVERY RECEIPT OF THE REPLACEMENT PRODUCT. If the defective Product is not returned to Us within ten (10) calendar days of confirmed delivery receipt of the Replacement Product, You will be assessed a non-returned device fee equal to the MSRP of the Replacement Product. WE RESERVE THE RIGHT TO REPLACE A DEFECTIVE PRODUCT WITH A NEW, REBUILT OR REFURBISHED ITEM OF EQUAL OR SIMILAR FEATURES AND FUNCTIONALITY, WHICH MAY NOT BE THE SAME MODEL OR COLOR AS THE PREVIOUS COVERED PRODUCT.

# ADDITIONAL BENEFIT INCLUDED IN THIS SERVICE CONTRACT - NO LEMON GUARANTEE

This Contract also provides a "NO LEMON GUARANTEE". During the Term, if Your Product has three (3) Repairs covered under Your Contract for the same problem and a fourth (4<sup>th</sup>) Repair is required for the same problem and considered covered under Your Contract ("Qualifying Service Repairs"), We will Replace Your Product with one of like kind and quality, but not necessarily same brand, or, at Our sole discretion, provide You with reimbursement equal to the fair market value of the Product as determined by Us based upon the age of the Product and subject to the "LIMIT OF LIABILITY" section. Any Repair services performed while Your Product is under its manufacturer's warranty period or in relation to accidental damage from handling (if purchased/applicable) are not considered to be Qualifying Service Repairs under this benefit.

#### PLACE OF SERVICE

For covered Claims, You are responsible for transporting Your Product to a service center authorized by Us (i.e. carry-in delivery or prepaid and insured shipment).

#### LIMIT OF LIABILITY

In addition to that which is noted in the "COVERAGE PLAN OPTIONS" section as applicable to "Your Plan", neither We nor the Retailer shall be liable for any incidental or consequential damages; including but not limited to: property damage, lost time or lost data resulting from the Breakdown of any Product or equipment, from delays in service or the inability to render service, or resulting from the unavailability of Repair parts/components. Neither We nor the Retailer shall be liable for any and all Pre-Existing Conditions (defined below) known to You, including any inherent Product flaws.

# WHAT IS NOT COVERED - EXCLUSIONS

## THIS CONTRACT DOES NOT COVER ANY CLAIM IN CONNECTION WITH OR RESULTING FROM:

- (a) Pre-Existing Conditions incurred or known to You ("Pre-Existing Conditions" refers to a condition that, within all reasonable mechanical or electrical probability, relates to the mechanical fitness of Your Product before this Contract was purchased);

IN NO EVENT WILL WE BE RESPONSIBLE FOR THE RESTORATION OF SOFTWARE OR DATA. OR FOR RETRIEVING DATA FROM ANY PRODUCT.
